### **RENTAL POLICIES:**

#### **I- Generalities:**

1. The garden "Pleine Nature" can accommodate up to 400 guests per event.
2. Event reservations are on a first come - first served basis.
3. Event ends at 2 am - Afterparty available upon request till 5 am.
4. Set-ups, including florists and caterers, must be approved by the first Party before payment is made. The actual set-up and take-down are not the garden's responsibility and must be done on the day of the event.
5. No tents, tables, chairs, ropes, wires or ties, or other materials shall be directly attached to or placed directly on top of any trees or shrubbery before prior approval by the first party. No digging of any holes. No cutting of any flowers or shrubbery. No use for confetti. Renters may be assessed fees for plant damage.
6. Vows and Venues s.a.r.l. will not assume any responsibility for loss of property of the wedding party, their guests, or vendors.
7. Vows and Venues s.a.r.l. offers insurance against car damage or physical incidence that might occur during the event.
8. **Providers, including caterers and fireworks companies, must be approved by Vows and Venues.** It is understood that Vows and Venues s.a.r.l. shall have no responsibility for the authorization to use the fireworks and/or for any damage that might occur to the guests or any third party.
  - **Any additional request concerning the lighting, or the sound system should be coordinated directly with Fadi Nahed on +961 03 29 77 78 – No other supplier is allowed to be outsourced.**

## **II- Event Detailed Package:**

### **OFFER 1:**

- Venue rental: includes access to the Welcome Drink Area, Ceremony Area, Reception Plaza, Dressing Rooms, Toilets.
- Light system: full lighting system for the whole venue - Dance Floor: 6 X 6 m.
- Sound system and DJ included. Any additional fee will be discussed directly with the sound expert, if a band is requested or the ceremony will take place in the venue.
- Valet parking available during the event.
- Generator 250 KVA and backup generator.
- Toilets, 6 for each gender with cleaning agents.
- Welcome hostesses: one hostess for every fifty guests.
- Coordination team for the day and night of the event.
- A furnished flat on the night of the wedding at the "Z Views" Mar Roukoz - Dekwaneh.
- "Pleine Nature Mobile Application" to help the couple plan their wedding and choose their suppliers.
- Tables and chairs for the dinner for **150 guests**: Natural wood color tables with X back shape chairs or white wood color tables with Plexiglass Tiffany chairs (Tables for the buffet, welcome drink furniture and cutlery are not included).

**TOTAL RENTAL COST: 6,000 USD + 100,000,000 LBP** (A total of 10,000 USD where 6,000 USD is paid in cash US Dollars and 4,000 USD is paid in LBP for the exchange rate of 25,000 LBP/1 USD = 100,000,000).

Rental Deposit: 100,000,000 LBP and 1,000 USD cash due with signed Wedding/Reception Agreement.

Second Payment: 2,500 USD cash one month prior to the wedding date.

Rental Balance: Remaining amount of 2,500 USD cash to be paid one week prior to the event.

**PAYMENT TERMS:**

Rental Deposit: 5,000 USD cash due with signed Wedding/Reception Agreement.

Second Payment: 5,000 USD cash one month prior to the wedding date.

Rental Balance: Remaining amount after confirming the final guests' number to be paid one week prior to the event.

**AFTERPARTY - OPTIONAL:**

- Can be celebrated in the Welcome Drink Area from 02:00 am till 05:00 am.
- Includes: a new setup in the welcome drink area, furniture, sound system and DJ, with ambient - dimmed lighting at an additional price of **1,000 USD**.

**CANCELLATION and REFUNDS:**

- 35% of the total amount is nonrefundable except in case of terrorists' acts, government regulations and restrictions i.e., road closure, embargo, curfew.

- No refunds will be given due to inclement weather or a couple break-up.
